PREAMBLE:

State Government has recently announced “SURYA-Gujarat” (Surya Urja Rooftop Yojana-Gujarat) GR dated 5th August 2019 referred above to give a further boost for promotion of solar rooftops in the state for residential sector. It was under the consideration of the Government to extend the “SURYA-Gujarat” subsidy scheme for Group Housing Societies / Residential Welfare Associations (GHS/RWA) to increase the scope for the benefits of the masses.

RESOLUTION:

In Continuation of the GR dated 5th August 2019 referred above, the Government is pleased to amend the aforesaid resolution after careful consideration, as follow:

In Para No.3 of the GR No. SLR-11/2015/401/B1 dated 05/08/2019, the following paragraph shall be added: -

“3 A “For Group Housing Societies / Residential Welfare Associations (GHS/RWA), the subsidy would also be available at a rate of 20% for solar roof top system for supply of power to common facilities of that GHS/RWA. The capacity eligible for the subsidy to GHS/RWA will be limited to 10kW per house and the total shall not exceed 500kW per GHS/RWA.

Common facilities shall include such assets of the GHS/RWA that are built for the use of all its residents such as water works, lift, street lights, gym, swimming pool, garden, etc.”

"SURYA-Gujarat" Scheme published vide GR dated 05th August 2019 stands amended to this extent.
